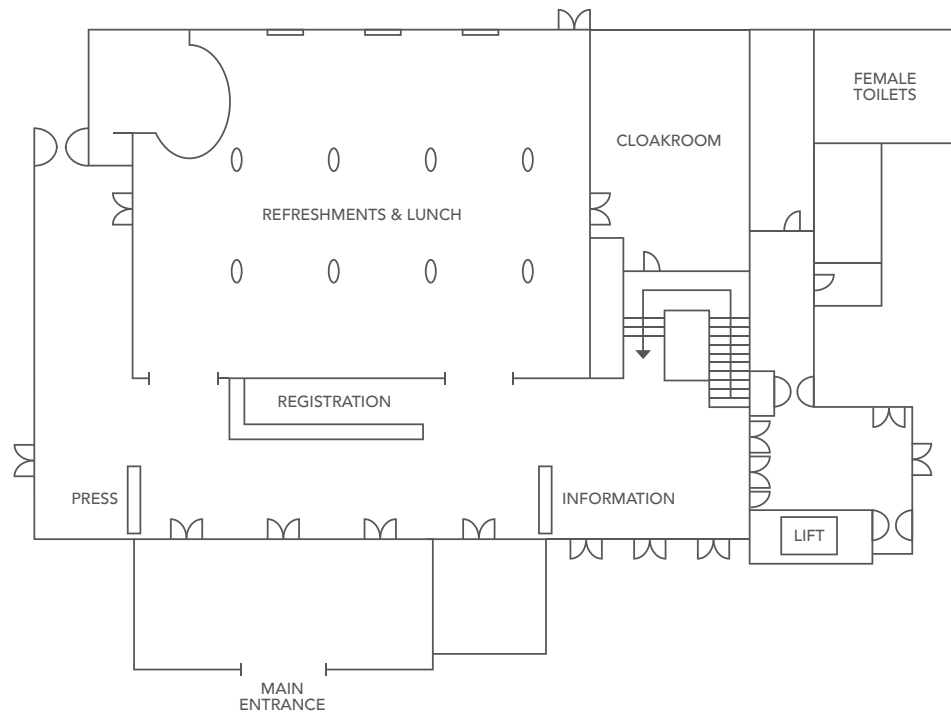

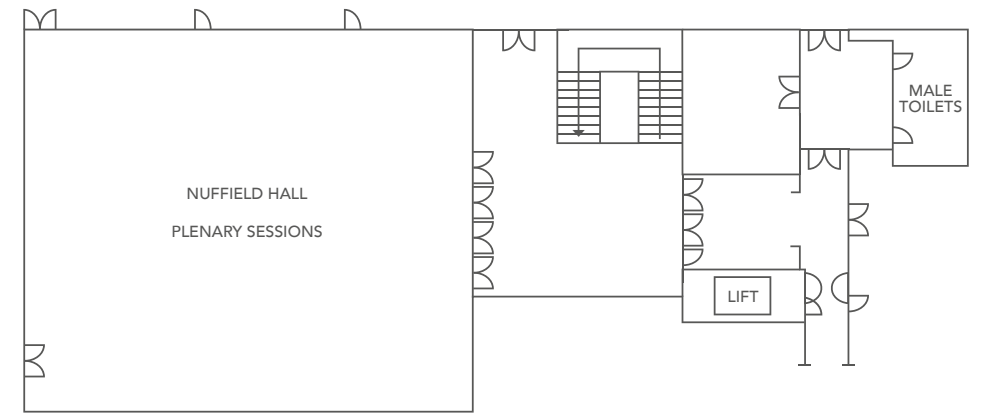

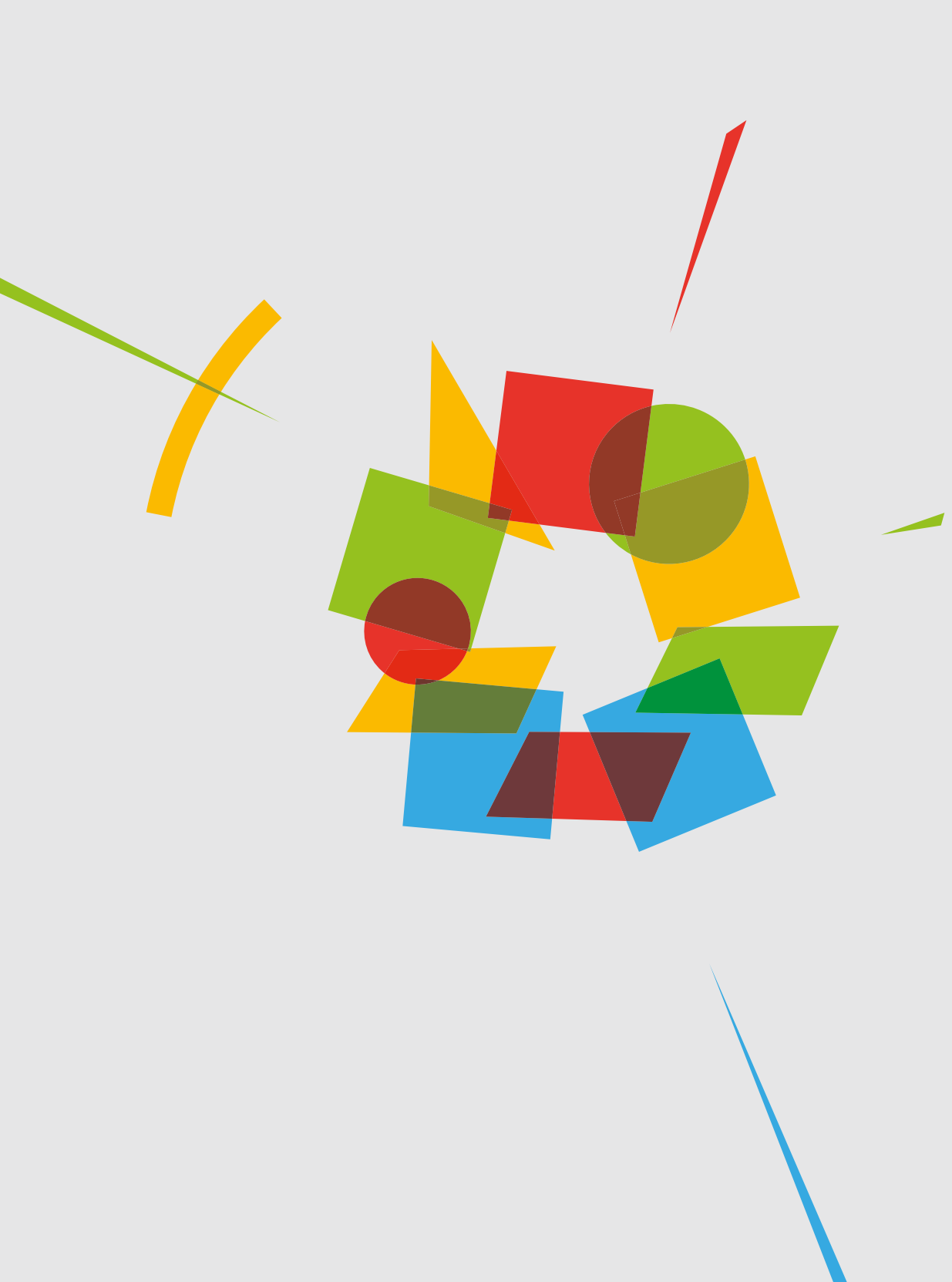

What is philanthropreneurship?

Philanthropreneurship is an entrepreneurial approach to the pursuit of philanthropy; it is giving that disrupts the status quo.

The term was originally coined in the early part of this century, but the co-chairs of the Philanthropreneurship Forum – His Excellency Amr Al-Dabbagh, Founding Chairman of Stars Foundation and Professor Rajesh Chandy, who holds the Tony & Maureen Walker Chair in Entrepreneurship at London Business School – are seeking to democratise its meaning: to recast philanthropy as more than the provenance of wealthy donors, and to disavow the notion that entrepreneurship is synonymous with 'profit'.

The Philanthropreneurship Forum will explore the dynamics of creative philanthropy, and how its practice can catalyse entrepreneurialism, innovation and cross-sector collaboration to make gains in the fight against global challenges.

This one-day event is co-convened by London Business School (LBS) and Stars Foundation. In its inaugural year, the Forum is bringing together 200 leaders from philanthropy, development, academia, government and the private sector to critically examine how to achieve social impact, ensure sustainability and deliver scalable progress for communities around the world.

The Forum's main content will be delivered through three plenary sessions on Impact, Scale and Sustainability.

The goal is to identify the critical insights each sector contributes in order to 'do things better', 'do things bigger' or 'make things stronger', respectively, and to surface the tension points between sectors that act as barriers to collaboration and progress.

Al-Dabbagh Group has four strategic business portfolios in Food, Housing, Petroleum & Autoservices and Packaging as well as an Incubation portfolio.

With the Giving principle, His Excellency is the Founding Chairman of the UK-based Stars Foundation, the global philanthropic arm of Al-Dabbagh Group. Stars supports disadvantaged children in the 100 countries with the highest under five-mortality rate as defined by UNICEF through a suite of initiatives and programs.

In the principle of Sustaining, His Excellency leads the "Club 32" initiative, created to empower the 32 members of the Al-Dabbagh family's 3rd generation, including his own five children, to become global leaders in the areas in which they are most passionate.

His Excellency brings the spirit of entrepreneurship into all his professional postings. Prior to assuming the Chair of Al-Dabbagh Group, he served two four-year terms in government as Chairman of the Board of the Saudi Arabian General Investment Authority (SAGIA), with a rank of Minister.



Dr Shahid Ansari

Dr Shahid Ansari is a faculty member in the accounting division at Babson College and is currently assigned to be the CEO of Babson Global, a wholly owned subsidiary of Babson College. He has previously served as the Provost and Dean of Faculty of Babson College.

Dr Ansari received his MBA from the Institute of Business Administration, Karachi and his Ph.D. in Accounting and Organizational Behavior from Columbia University. He has been a faculty member at UCLA, NYU, the Naval Postgraduate School and California State University Northridge before coming to Babson. He has also been a visiting faculty at INSEAD, Fontainebleau, France, Macquarie University, Australia and Pretoria University, South Africa, Marshall School at USC, Rice University and Darden Graduate School of Business, University of Virginia.

Dr Ansari has won several awards and honors for distinguished teaching during his career. The Consortium for Advanced Management International (CAM-I) awarded Dr Ansari the prestigious Bob Bonsack Award for Distinguished Contribution to the Advancement of Cost Management for his thought leadership. He also received the Jim Bulloch Innovation in Management Accounting Education Award from the American Accounting Association.

Dr Ansari has extensive consulting and executive education experience with major national and multi-national firms including several years as a faculty for Shell Learning Center in Houston and Holland. He has served on the Board of Directors of many new start-ups, some of whom have grown into significant mature businesses.



Zeinab Badawi

International Broadcaster and Chair of
the Royal African Society

Zeinab was born in the Sudan but moved to London at the age of two. Her father, prominent Sudanese - Mohammed-Khair El Badawi, was involved in pre-independence politics in Sudan.

Zeinab studied Philosophy, Politics and Economics at Oxford University and a Masters Degree (awarded with a distinction) on Middle East History and Anthropology at London University. In July 2011 Zeinab was awarded an honorary doctorate by SOAS, London University for her services to international broadcasting.

Zeinab has extensive experience in television and radio, working on a range of programmes. She is one of the best known broadcast journalists working in the field today. In 2009 she was awarded International TV Personality of the Year by the Association of International Broadcasters, and in 2011 was named in Powerlist 2012 (published by Powerful Media Ltd) as one of Britain's top 100 most influential members of the black community.

She is the current Chair of the Royal African Society, a patron of the BBC Media Action (the charitable arm of the BBC), and a former trustee of the National Portrait Gallery. She has been a board member of the British Council, a former Chair of the London based freedom of speech campaign organisation, Article 19, and a board member of the Overseas Development Institute.

Zeinab also presents the World Debates and Intelligence Squared Debates on the BBC.

Tania Bryer is a British television broadcaster with a wealth of experience. She is currently working as Host and Executive Producer for the International business network CNBC on her critically acclaimed series 'CNBC Meets..', gaining unprecedented access to global figures including President Bill Clinton, Archbishop Desmond Tutu, Mayor Boris Johnson, Cherie Blair CBE, Andre Agassi, will.i.am, Carla Bruni-Sarkozy, Matt Damon, Lang Lang and President Jimmy Carter.

She reviews the newspapers weekly on Sky News Sunrise, and has previously presented and co-produced several series for both Sky News and Sky One.

A highly skilled host and moderator, she regularly chairs conferences, award ceremonies and panel discussions around the world including The World Economic Forum at Davos, The Women's Forum in Deauville and Intelligence Squared in London and hosts many International charity events including The Hope Galas in Jordan, Dubai and Washington D.C. for their Majesties King Abdullah and Queen Rania of Jordan.

She is Chair of the National Events Committee for Cancer Research UK, A Patron of the Alzheimer's Society and has recently become an Ambassador for the Health Lottery.

Bryer holds a B.Sc. in International Politics from The School of Foreign Service at Georgetown University, Washington D.C.



Professor Rajesh Chandy

Tony & Maureen Walker Chair in Entrepreneurship
London Business School

Rajesh Chandy holds the Tony and Maureen Wheeler Chair in Entrepreneurship and is a Professor of Marketing at London Business School. He serves as Academic Director of London Business School's Deloitte Institute for Innovation and Entrepreneurship, and is faculty director of the school's Market Driving Strategies executive education course.

Chandy's areas of expertise include innovation, technology management, emerging markets, and marketing strategy. During 2006-2008, he served as a member of the US Secretary of Commerce Advisory Committee on Measuring Innovation in the 21st Century Economy. He serves on the brain trust of the Global Innovation Forum, and has been a member of the American Marketing Association's Academic Council and its Knowledge Development Coalition.

Chandy's research and publications have received several awards, including the Journal of Marketing Harold Maynard Award for contributions to marketing theory and thought, and the AMA TechSIG Award for the best article on Technology and Innovation (twice). He has received the AMA Early Career Award for contributions to marketing strategy research, and has been named an MSI Young Scholar.

Chandy is as an Area Editor for the Entrepreneurship and Innovation area at Management Science, and is a current or former member of the editorial boards of the

Journal of Marketing Research, Journal of Marketing, IEEE Transactions on Engineering Management, International Journal of Research in Marketing, and Marketing Letters.

Fortune magazine described Chandy's findings on innovation as "an unorthodox and bracing set of management principles," and the Academy of Management Perspectives called it "groundbreaking," and "invaluable". He has received a number of teaching awards, including the Outstanding Professor of the Year Award, the Award for Excellence in Teaching, and the Outstanding Faculty Dedication Award. His consulting and executive education clients include Nordea, Novo Nordisk, Toshiba, St. Jude Medical, 3M, Philips, Commonwealth Microfinance Limited, American Medical Systems, Hutchinson Technology, Microsoft, Mundipharma, Rexam, Wrigley, GfK, Futuredantics, Vodafone, Deutsche Telekom, Bertelsmann, and Telenor, among others.

Chandy received his PhD in Business Administration in 1996 from the University of Southern California.



President Bill Clinton

Founder of the Clinton Foundation
42nd President of the United States

William Jefferson Clinton, the first Democratic president in six decades to be elected twice, led the U.S. to the longest economic expansion in American history, including the creation of more than 22 million jobs.

After leaving the White House, President Clinton established the William J. Clinton Foundation with the mission to improve global health, strengthen economies, promote healthier childhoods, and protect the environment by fostering partnerships among governments, businesses, nongovernmental organizations (NGOs), and private citizens to turn good intentions into measurable results. Throughout the Foundation's history and growth, Secretary Clinton and Chelsea offered their voice, vision, and counsel. To recognize their past contributions and acknowledge their role in shaping the Foundation's future, the Foundation was renamed the Bill, Hillary & Chelsea Clinton Foundation.

Today the Foundation has staff and volunteers around the world working to improve lives through several initiatives, including the Clinton Health Access Initiative, which is helping 5 million people living with HIV/AIDS access lifesaving drugs. The Clinton Climate Initiative, the Clinton Development Initiative, and the Clinton Giustra Enterprise Partnership are

applying a business-oriented approach to fight climate change worldwide and to promote sustainable economic growth in Africa and Latin America. In the U.S., the Foundation is working to combat the alarming rise in childhood obesity and preventable disease through the Alliance for a Healthier Generation and the Clinton Health Matters Initiative. Established in 2005, the Clinton Global Initiative brings together global leaders to devise and implement innovative solutions to some of the world's most pressing issues. So far, nearly 2,300 Clinton Global Initiative commitments have improved the lives of more than 400 million people in 180 nations.

In addition to his Foundation work, President Clinton has joined with former President George H.W. Bush three times – after the 2004 tsunami in South Asia, Hurricane Katrina in 2005, and Hurricane Ike in 2008, and with President George W. Bush in Haiti in the aftermath of the 2010 earthquake. Today the Clinton Foundation supports economic growth, job creation, and sustainability in Haiti.

President Clinton was born on August 19, 1946, in Hope, Arkansas. He and his wife Secretary Hillary Rodham Clinton have one daughter, Chelsea, and live in Chappaqua, New York.



Dr Delos 'Toby' Cosgrove

President & CEO
Cleveland Clinic

Delos M. Cosgrove MD, is President and CEO of Cleveland Clinic. He heads a \$6 billion healthcare system comprised of Cleveland Clinic, 8 community hospitals, 16 family health and surgery centers, Cleveland Clinic Florida, Lou Ruvo Center for Brain Health, Las Vegas, Cleveland Clinic Toronto, and Cleveland Clinic Abu Dhabi.

Dr Cosgrove received his medical degree from University of Virginia School of Medicine, completed clinical training at Massachusetts General Hospital, and Brook General Hospital in London. He earned an undergraduate degree from Williams College, Williamstown, Massachusetts. In 1967, he was a surgeon in the U.S. Air Force, serving in Da Nang, Vietnam. He was awarded the Bronze Star and Republic of Vietnam Commendation Medal.

Dr Cosgrove joined the Cleveland Clinic in 1975, and was named chairman of the Department of Thoracic and Cardiovascular surgery in 1989. He performed over 22,000 operations and earned an international reputation in cardiac surgery valve repair before his retirement in 2006. He holds 30 patents for medical innovations.

He has received numerous awards and is ranked among Modern Healthcare's "100 most powerful people in healthcare" and "most powerful physician executives." His book, "The Cleveland Clinic Way" was published by MacGraw-Hill Education in 2014.



Professor Eric Grimson

Chancellor for Academic Advancement
Massachusetts Institute of Technology

W. Eric L. Grimson, the Bernard M. Gordon Professor of Medical Engineering and Professor of Computer Science and Engineering, has served as the Chancellor for Academic Advancement at the Massachusetts Institute of Technology since fall 2013. As one of the Institute's most senior academic officers, Professor Grimson is a central advisor to President Rafael Reif on the Institute's fundraising campaign's shape and strategy.

A member of the MIT faculty since 1984, Professor Grimson previously served as Chancellor of the Massachusetts Institute of Technology. He is internationally recognised for his research in computer vision, especially in applications in medical image analysis.

In addition to research, Professor Grimson continues to teach introductory Computer Programming courses, including an online MITx course. He has taught nearly 11,000 MIT undergraduates and served as the thesis supervisor to almost 50 MIT Ph.D.s. Professor Grimson is a Fellow of the Association for the Advancement of Artificial Intelligence and of the Institute of Electrical and Electronics Engineers, and holds a Doctor of Letters (honoris causa) from Dalhousie University.

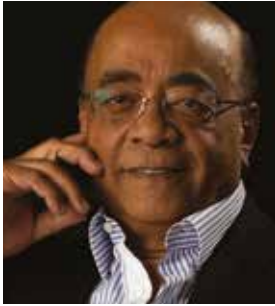

Dr Ibrahim is the Founder and Chair of the Mo Ibrahim Foundation which he established in 2006 to support good governance and exceptional leadership on the African continent.

The Foundation focuses on four major initiatives to stimulate debate around, and improve the quality of, governance and leadership in Africa: the Ibrahim Index of African Governance (IIAG); the Ibrahim Prize for Achievement in African Leadership; the annual Ibrahim Forum and the Ibrahim Fellowships and Scholarship programmes.

Sudanese-born, Dr Ibrahim has a distinguished business career. He is the Founder and former Chairman of Celtel International, one of Africa's most successful companies.

Dr Ibrahim is also the Founding Chairman of Satya Capital Limited, a private equity fund exclusively focused on Africa.

Dr Ibrahim has received numerous honorary degrees and fellowships from a range of academic institutions and is also the recipient of a number of awards.

Dr Ibrahim is also a member of the B-team; Clinton Global Initiative; The Giving Pledge; Global Philanthropist Circle (Synergos) as well as a member of UNCTAD's panel of Eminent Persons.

In 2008, Dr Ibrahim was listed by TIME magazine as one of the 100 most influential people in the world.



Dr Clint Korver

COO
NovoEd

Dr Clint Korver is the COO of NovoEd, a social eLearning platform that powers programs at Stanford, Wharton, Princeton, Berkley, Michigan, University College London, and other elite institutions.

Clint is a serial entrepreneur. Prior to joining NovoEd, he co-founded Ulu Ventures, a Silicon Valley venture capital firm where he made over 60 investments in technology startups, including Palantir, SOFI, Inkling, Remind, Clever, and NovoEd. He co-founded and led Stanford Angels and Entrepreneurs, Stanford's official angel investing group. He co-founded and led the Kauffman Fellows Academy, the online education arm of the Kauffman Fellows Program the premier venture capital training program. He also co-founded and led four Silicon Valley startups.

Clint is a teacher and author. He has taught technology entrepreneurship, startup boards, and ethics at Stanford University. He created one of Stanford's first Massive Open Online Classes (MOOCs) in entrepreneurship and delivered it using the NovoEd platform. He co-authored Ethics for the Real World (Harvard Business Press 2008). He earned a PhD and MS in Management Science and Engineering from Stanford and a BA with honors in Mathematics from Grinnell College, where he currently serves as Chair of the Board of Trustees.



Senator George Mitchell

George J. Mitchell entered the U.S. Senate in 1980 and went on to an illustrious career in the Senate that spanned 14 years. In January 1989, he became Senate majority leader. He held that position until he left the Senate in 1995. Earlier he served as U.S. Attorney and U.S. District Court Judge.

In 1995-99 he chaired peace negotiations in Northern Ireland, for which he received numerous awards and honors, including the Presidential Medal of Freedom, the highest civilian honor the U.S. government can give; the Philadelphia Liberty Medal; the Truman Institute Peace Prize; the German (Hesse) Peace Prize; and the United Nations (UNESCO) Peace Prize.

At the request of President Clinton and Israeli and Palestinian leaders, Senator Mitchell served in 2000-01 as chairman of an international fact-finding committee on violence in the Middle East. At the request of President Obama he served in 2009-11 as the U.S. Special Envoy to the Middle East.

He served as chairman of The Walt Disney Company, and as chairman of the International Crisis Group, a nonprofit organisation dedicated to the prevention of crises in international affairs.

He is now Chairman Emeritus of the global law firm DLA Piper.

In 2008 Time Magazine described him as one of the 100 most influential people in the world.



Paul Polman

CEO
Unilever

Paul Polman has been CEO since 1st January 2009. Under his leadership Unilever has set out an ambitious vision to double its size while reducing its overall environmental footprint and increasing its positive social impact.

Paul is Chairman of the World Business Council for Sustainable Development, a member of the International Business Council of the World Economic Forum and serves on the Board of the UN Global Compact. He is also on the Board of the Global Consumer Goods Forum.

At the invitation of the UN Secretary General, he recently served on the High Level Panel of Eminent Persons looking at the Post 2015 Development Agenda and previously acted as co-chairman of the B20 group of companies reporting to the G20 on Food Security. He is a member of the European Resource Efficiency Platform chaired by Environment Commissioner Janez Potocnik, and has agreed to serve at the invitation of former Mexican President, Felipe Calderon, on the International Council of the Global Commission on the Economy and Climate. He was recently asked by the UK Prime Minister to be a British Business Ambassador.

Since 2010, Paul has been a non-executive director of the Dow Chemical Company.

In recognition of his contribution to responsible business, Paul is a former recipient of the Atlantic Council Award for Distinguished Business Leadership and the CK Prahalad Award for Global Sustainability Leadership. Last year he received the World Wildlife Fund Duke of Edinburgh Conservation Medal and has just been awarded a Lifetime Achievement Award by the Rainforest Alliance.

Paul began his career at Procter & Gamble in 1979, holding many senior executive positions, including Group President of Europe. He moved to Nestle in 2005, where he was the CFO and Executive Vice President for the Americas.

He earned a BBA/BA from the University of Groningen, Netherlands, in 1977 and an MA Economics and MBA finance/ international marketing from the University of Cincinnati in 1979. He has been awarded honorary degrees from the Universities of Northumbria, Newcastle, UK, in 2000 and the University of Cincinnati, USA, in 2009.

Married with three children, Paul is Chairman of Perkins School for the Blind International Advisory Board and serves as President of the Kilimanjaro Blind Trust.

Kate Silverton is a highly accomplished, versatile journalist and popular presenter of BBC news, current affairs and entertainment programmes. She has won plaudits for her reporting from Iraq, and is no stranger to conflict, having covered several of the world's troubled and beleaguered regions, including reporting from the front line in Afghanistan.

Seeing the limited impact of charity-buying, he founded the BOP HUB as a platform to end poverty by mobilising and creating a vibrant massive economy for the 4 billions at the Base of Pyramid.

Jack was named Schwab Fellow of the World Economic Forum, Ashoka Global Fellow, Synergos Senior Fellow, and Time Magazine Hero of the Environment 2008.

One third of Bangladesh floods annually during the monsoon season, but extreme floods cover up to two thirds. Due to floods, thousands of schools are forced to close and many children miss school days.

Shidhulai Swanirvar Sangstha came up with a creative solution 'floating school' to address this issue and brought the school to the students during the flooding. Also the organisation runs a fleet of boats acting as libraries, adult education centers and solar workshops. Boats themselves are outfitted with solar panels that power computers, lights and other equipment. But the boats bring more than services to these cut-off areas - they bring electricity. Shidhulai also runs floating clinics that have doctors and paramedics.

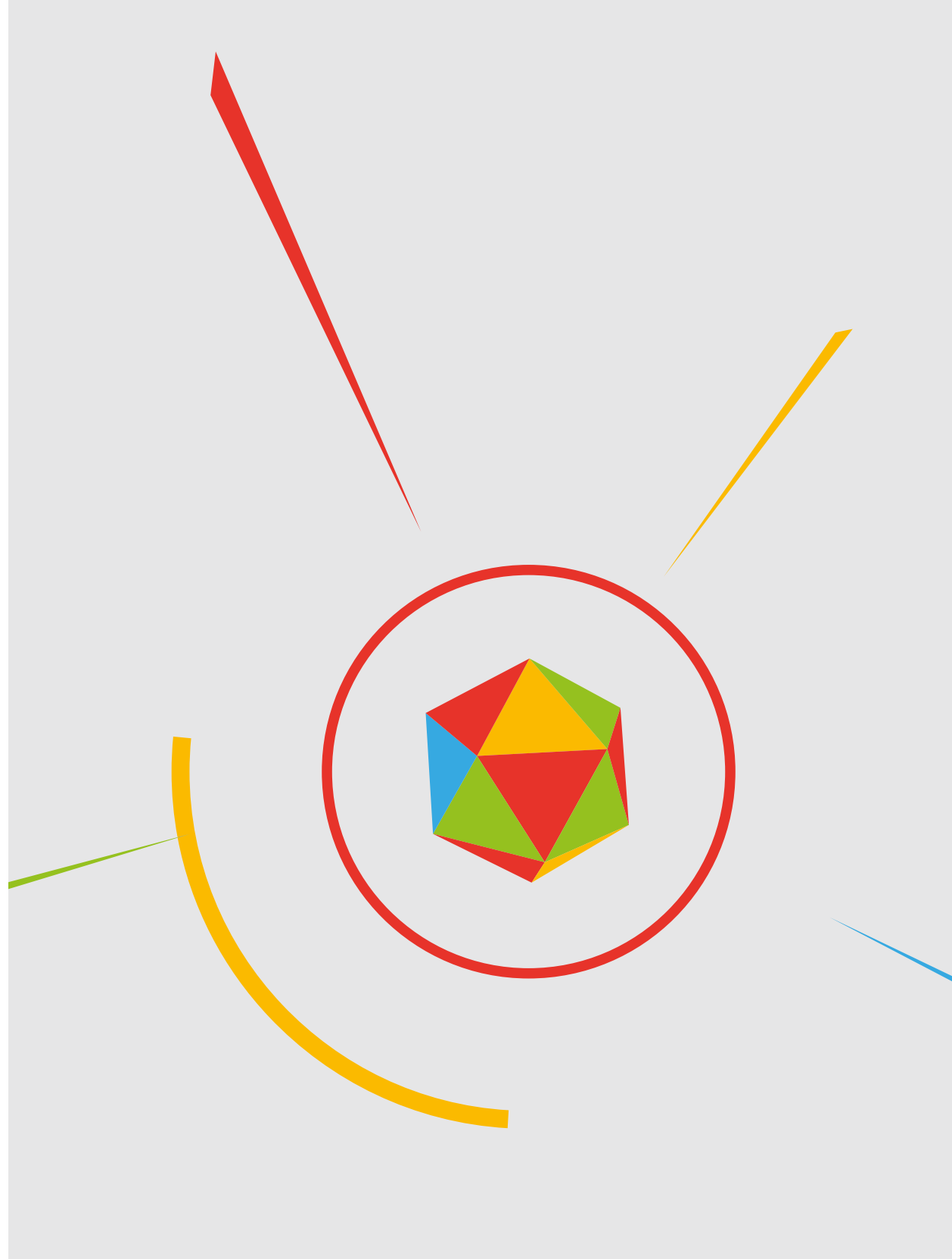

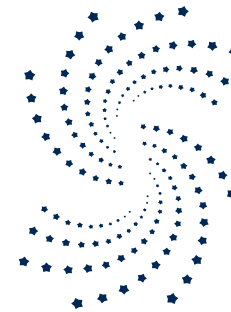
